We acknowledge receipt of constitution of Inspection Committee in connection with our application for Extension of Provisional Affiliation.

With regard to the specific compliance, we wish to inform the following :

1. The School has been running since 1972 at two different locations to provide adequate space for all classes, labs and for School Auditorium. All the buildings are adjacent. We got the Middle School approval from CBSE, Delhi, in the year 1972 and subsequently approved for Class IX and X in the year 1973 and for Senior Secondary in the year 1977 for the same location. Also we got approval from CBSE in the year 1984 for Integration of our Primary Department (two different location) with Senior Secondary Department. The copies of approval are enclosed for your kind perusal. The details of infrastructure, classes that are running at each site, area of each site, distance between the two sites are enclosed.
2. Due to heavy demand from parents in the locality where there is no CBSE School nearby around 2 kms we had to admit slightly more (10 to 15 more) than the optimum number of students in some classes. We are gradually reducing it and we assure we will maintain the optimum strength in all classes in the coming years. The revised list of enrolment classes / section wise is enclosed herewith.

PRIMARY CLASSES FOR RENOVATION WORK AT SCHOOL CAMPUS**

Greetings for a happy and prosperous New Year 2024.

We wish to bring to your kind notice that we require temporary shifting of classes from Door No.169/83, Big Street, Triplicane, Chennai – 600005 to the Golden Jubilee Annexe building at Door No. 15, Peyalwar Street, Triplicane, Chennai-600005, which is 500 meters away from the School building, since we need to carry out substantial renovation work at the School Campus in 2024-25.

The School building is more than 50 years old and is in need of renovation. In recent years, Tamil Nadu (especially Chennai) has been witnessing heavy rains and floods. It is a cause of concern for the safety and security of the students considering the cyclone effects that has taken a toll on old buildings.

Furthermore, the renovation work includes enhancing infrastructure, to provide modernised digital classrooms to empower students with 21<sup>st</sup> century skill sets as suggested by National Education Policy 2020 on ICT in School Education by MHRD. In this regard, planning and execution of renovation work is time consuming.

The above mentioned project is planned to start tentatively from May 2024. Hence, temporary shifting (repositioning) of the classes is essential, to ensure smooth running of the school in the upcoming academic years.
