All payments are subject to the following conditions: -

All Fees quoted are in Indian Rupees. The school reserves the right to change the fees at any time.

1. The User agrees and accepts the payment facility services to the school, that are provided by Payment Gateway Service Provider **INDIAIDEAS.COM LIMITED** (BillDesk) to carry out fee payments to the school.
2. While the School, will take all reasonable steps to ensure the accuracy of the payment details, the school is not liable for any error. 3. The User agrees that in case of any queries or disputes on Payment done the same will be informed and settled directly with the school.
