- (25) The classrooms and laboratory should be as per the building plan approval. Any alteration in existing classrooms or creation of additional classrooms should be done with the proper approval of the concerned Authorities.
- (26) Drinking water facility Toilet facility & Classroom should be provided in accordance with Student Strength
- (27) The Number of persons accommodated in the school building should not exceed the number sanctioned in the D - Licence.
